City Council Proceedings
May 9, 2023

The Mayor and City Council of the City of Tilden met in regular session on Tuesday, May 9, 2023 at 7:30pm at the Tilden Council Chambers. Notice of the meeting was given by publication in The Tilden Citizen/Meadow Grove News on April 26, 2023 and by posting at four locations within the city.

- (1) Mayor Tom Nelson opened the meeting at 7:30 pm and the Clerk recorded the proceedings.
- (2) Declaration of open meetings act.
- (3) ROLL CALL: Mayor Tom Nelson. Council Members: Allen Smidt, Travis Rutjens, Allen Miller, Darrell Wyatt. Absent – Halle Hart, Lisa Meyer.
- (4) PLEDGE OF ALLEGIANCE
- (5) MAYOR’S OPEN DISCUSSION – Mayor Nelson mentioned that iron prices are still at a high price right now so citizens have a good opportunity to get scrap cleaned up and unlicensed vehicles taken care of. The City is also looking for 6 volunteers from the public to serve on the citizens advisory committee. The committee would meet once every 6 months at a minimum to bring new ideas forward for improvements. The City is also still looking for a representative to serve on the Madison County Zoning Board.

- (7) REPORTS BY CITY DEPARTMENTS-Written reports are kept on file in the City office and are available for public viewing.
- (8) TILDEN ALLEY PAVING IMPROVEMENT – Motion made by Wyatt, seconded by Miller to approve the plans and specs, authorize ACES to advertise for bids, and set the bid letting date for June 13, 2023 at 3:30 pm. RCV: Yes – Miller, Wyatt, Rutjens, Smidt. No – None. Absent – Hart, Meyer. Approved.
- (9) LEGION – Motion made by Rutjens to approve the SDL request for June 10, 2023 including the public space, seconded by Miller. RCV: Yes – Miller, Wyatt, Rutjens. Smidt. No – None. Absent – Hart, Meyer. Approved.
- (11) NPPD – Brittney Koenig was present to discuss the retail updates and meet the Council
- (12) POOL ROOF – Motion to reject the only bid made by Rutjens, seconded by Miller. RCV: Yes – Smidt, Rutjens, Miller, Wyatt. No – None. Absent – Meyer, Hart. Approved.
- (13) BURGER BASH – Motion made by Rutjens, seconded by Miller to allow Thriftway Market to close a portion of 2nd Street for the Burger Bash event. RCV: Yes – Miller, Wyatt, Smidt, Rutjens. No – None. Absent – Meyer, Hart. Approved.
- (14) NUISANCE – Complaints and concerns discussed.
- (10) TYMC – Request to place mud volleyball pits in the same location as prior years. Council agrees to allow that as long as property is cleaned up afterwards.

With no further business to come before the council, Miller made a motion to adjourn, seconded by Wyatt. Meeting was adjourned at 8:31 pm.
